

How to apply - Fresh OCI Card for Minors

Step 1- Filling up the application form.

The application must be filled and submitted online at the link: <https://ociservices.gov.in/>. Please carefully read the details and various provisions while submitting application.

NOTE: All fields/columns in the application form are mandatory to be filled-in.

Step 2 – Prepare and collect documents required for the application. All documents must be self attested by the applicant unless instructed otherwise.



NOTE:

i) All documents are mandatorily required to be uploaded.

ii) While uploading a document, if no specific option under 'document type' dropdown is available to choose, that document can be uploaded in any available 'document type'. Moreover, all documents can be uploaded in a combined .pdf file within a specific 'document type'.
